# **VACANCIES**

Applications are invited from qualified candidates to fill the following vacancies of the Telecommunications Regulatory Commission of Sri Lanka (TRCSL).

## Post of Telecommunications Officer (Grade II)

## 2. Job Description

- Maintenance of Measuring and Testing Equipments.
- Conducting Technical standards and Compliance tests.
- 3. Attending to works on Interference Measurement, field strength and Power Measurements.
- 4. Conducting technical investigations and submission of reports.
- 5. Providing Technical assistance for procurement of technical equipments and other related activities.
- Assisting the management in executing the duties and functions of the TRCSL.

## 3. Required Educational / Professional Qualifications:

### **External Candidates**

A National Diploma or similar or a higher academic/vocational qualification, (not below the N.V.Q Level 6) in Electronics or Telecommunication, conferred either by a university recognized by the University Grant Commission or by an Institute of Technological Training recognized by the Commission

#### AND

03 years of post-qualifying experience in Telecommunication field

#### Internal Candidates

A National Diploma or similar or a higher academic/vocational qualification, (not below the N.V.Q Level 6) in Electronics or Telecommunication, conferred either by a university recognized by the University Grant Commission or by an Institute of Technological Training recognized by the Commission

#### AND

05 years satisfactory service experience on permanent basis in Associate/ Operational/ Management Assistant/ Technical or Primary Level in TRCSL.

- 4. Recruitment Procedure Through a competitive examination followed by a structured interview. Appointments will be made purely in the order of merit, obtained through the aggregated marks of the competitive examination and the structured interview.
- 5. Salary Telecommunications Officer TRC 5.2 40,000 –(10x750)-(10x1,000)-(10x1,250)-(10x1,500)- 85,000 All new appointments to these posts will be placed in the initial step of the salary scale relevant to the Grade II of this Employment category. However, salary of persons recruited internally will be determined in terms of the provisions in Codes of Rules on Appointments and Remunerations of the TRCSL or (in absence of such provisions), as far as relevant, in terms of Chapter VII of the Establishment Code.
- Age 18-45 (The upper age limit will not apply to internal candidates).

## 7. General Conditions

- Applicants who do not possess the required qualifications as at the closing date of applications will not be considered.
- 2. Any form of canvassing will be a disqualification.
- The Telecommunications Regulatory Commission of Sri Lanka (TRCSL) reserves the right to decide the number of positions to be filled or postpone/cancel the recruitment.
- 4. The TRCSL is a regulatory authority, wherein any person being recruited for employment in the TRCSL shall not promote, advance, or advocate directly or indirectly for appointment or employment of his/her spouse or any member of the family in or to a position in an institution that is under the regulatory control of the TRCSL.

## 8. Method of Application

- Applicants who possess the required qualifications should forward self-prepared application giving full bio-data together with copies of educational / professional qualifications and details of work experience.
