## Post of Director General - HM 2-1

The Director General is the Chief Executive Officer of the Authority. The Director General is accountable and responsible for all the activities, and administrative and financial affairs of the Authority under the general direction and control of the Board of Directors. He/She has to exercise, perform and discharge powers, functions and duties of the Board as may be delegated by the Board and provide leadership and encouragement to the staff of the Authority, for excelling in official achievements.

## Qualifications and Experience

External: A Bachelor's degree in Management, Public Administration, Marketing, Law, Economics, Accountancy, Commerce, Agriculture or Science from a University recognized by the University Grants Commission.

## And

A Postgraduate degree (Masters) qualification in relevant field with 10 years post qualified experience with a total of 18 years Postgraduate Managerial Level experience of which 05 years should be in a Senior Managerial Level in a Corporation, Board or a reputed Mercantile Establishment.

#### Or

A fellow member of a recognized professional accounting body with at least 18 years post qualified experience in a business or commercial environment in Managerial Level of which at least 05 years should be in a Senior Managerial Level in a Corporation, Board or a reputed Mercantile Establishment.

#### Or

Attorney-at-Law with at least 18 years Post qualifying experience in a business or commercial environment in managerial level of which at least 5 years should be at a Senior Managerial level.

Internal: Five years (05) satisfactory service in a post of Director in the Senior Manager category of the Consumer Affairs Authority.

## Remuneration and other benefits

Age: Age should be not less than 40 years and not more than 55 years. The upper age limit will not be applicable to the internal applicants.
