VACANCIES

Applications are invited from citizens of Sri Lanka having the qualifications and experience specified below and preferably having worked previously in Government or private large projects for the following posts on fixed term contract basis for the Moragolla Hydropower Project (MHP).

1. ENVIRONMENTAL OFFICER - One Vacancy

1.1 Qualifications and Experience

- First degree in Engineering, Physical Science, Biological Science, Environmental Science, Natural Resources Management, Forestry, Agriculture or any other related field obtained from a recognized university.
- Post graduate qualifications in Environmental Science or any related field with experience in Environmental Monitoring, Watershed Management or any related activity will be an added qualification.
- Minimum 05 years work experience as an Environmental Officer in recognized organization. Experience in government or private sector large projects will be an added qualification for selection.

1.2 Professional Competencies

- Ability to deliver technical services related to Environmental Impact Monitoring and suggest mitigation measures as required by the project as and when necessary.
- Ability to handle project environmental related activities in the required area of specialization independently.
- Ability to function effectively in a team environmental inspiring trust and co-operation of other team members.
- Ability to analyze and resolve environmental implementation problems related to his/her field.
- Experience in handling the social safeguard issues related to Resettlement and Environmental impacts
- Computer literacy
- Ability to communicate effectively
- Good public relations skills.
- High level of proficiency in written and spoken English
- Proficiency in written and spoken Sinhala will be an added advantage.

1.3 Duties: The Environmental Officer shall assist the Project Director/Project Engineer (REM) in the implementation of the Environment Management Plan of the project and the monitoring requirements specified under the Moragolla Hydropower Project.

2. CIVIL SUPERINTENDENT - Two Vacancies

2.1 Qualifications and Experience

- National Diploma in Technology in Civil Engineering with 03 years of experience in the relevant field
OR
National Certificate of Technology in Civil Engineering with 05 years of experience in the relevant field
OR
Equivalent qualification with minimum 05 years of experience in the relevant field.
- Work experience as a Civil Superintendent in Government or Private sector large projects will be an added qualification for selection.

3. CLERK - Two Vacancies

3.1 Qualifications and Experience

- Passes in six subjects at the GCE (O/L) Examination with at least five credit passes including Sinhala, English and Mathematics in one sitting.
- Knowledge of MS Office/Access Software applications.
- Sinhala and English word processing.
- Sufficient knowledge of English to communicate with foreign consultants and contractors
- Minimum 05 years work experience as a Clerk in recognized organization. Experience in Government or private sector large projects will be an added qualification for selection.

4. DRIVER - Two Vacancies

4.1 Qualifications and Experience

- Passes in six subjects at the GCE (O/L) Examination including Sinhala and Mathematics in one sitting.
- Applicants should have possessed a certificate competence with good record issued by the Commissioner of Motor Traffic to drive D Class or Higher Class vehicles for at least five (05) years.
- In the case of applicants who have been awarded a certificate by driving schools conducted by the Ministry of Transport or Ministry of Youth Affairs & Employment, the requirement of possessing the certificate of competence for five years is waived.
- Applicants should have a minimum height of 5 feet and 3 inches.
- Applicants should possess a sound knowledge of Highway Code and should be physically fit to driving during day and night and must have good eyesight and a good hearing.
- Minimum 05 years work experience as a Driver in recognized organization. Experience in Government or Private sector large projects will be an added qualification for selection.

5. SEMI-SKILLED FIELD EMPLOYEE - Two vacancies

5.1 Qualifications and Experience

- Passes in six subjects at the GCE (O/L) Examination including Sinhala and Mathematics in one sitting.
- Minimum 03 years work experience as a Labourer in technical fields in recognized organizations. Experience in Government or Private sector large projects will be an added qualification for selection.
