## **VACANCY**

Applications are invited from Sri Lankan applicants for the Post of Assistant General Manager (Production) of the Sri Lanka Ayurvedic Drugs Corporation.

### **Assistant General Manager (Production) - 01 Post**

#### **Basic Educational Qualifications and Professional Experience:**

##### **External Applicants**

Degree in Mechanical Engineering / Production Engineering Science / B.Sc. (Chemistry) from a University recognized by the University Grants Commission along with MSc./MA Degree in above subjects or Associate Membership of a reputed Professional Institute

##### **And**

Should have at least 15 years experience in a managerial level position in government or government institution after obtaining the degree and should have at least five years experience in the production of drugs out of the above 15 years.

##### **Internal Applicants**

Should have completed at least five (05) years of satisfactory service period in the relevant subject field in Class 1 of the Management Service Category.

##### **Age:**

Should be not less than 35 years and not more than 45 years as at 12.06.2017. Maximum age limit is not applicable to internal applicants.

##### **Others:**

- Every applicant should be a citizen of Sri Lanka.
- Should be physically and mentally fit to discharge the duties entrusted to the post in an efficient manner and to serve in any part of the island.
- Should have an excellent moral character.

##### **Method of Recruitment:**

Recruitments will be made as per the recruitment procedure through a structured interview conducted by a Board appointed by the Appointing Authority.

Appointees should contribute 8% to the Employees' Provident Fund and the Employer will contribute 12%. In addition to that an amount equivalent to 3% of the appointee will be contributed by the employer to the Employees' Trust Fund.

Applicants presently serving in Government Departments, Government Corporations and Statutory Boards should direct their applications through the Heads of the respective institutions. Complete bio-data and certified photocopies of the relevant certificates should be attached to the application. Applications without the certified copies of certificates will be rejected.
